# **Privacy Policy**

South West Scaffolding Limited are committed to protecting your privacy and compliance in line with the General Data Protection Regulations applicable to the United Kingdom. We respect the privacy rights of our users and recognise the importance of protecting the information collected about you. As you browse our website and whenever you communicate with us, we collect information.

By providing us with your personal information, you consent to the collection and use of any information you disclose in accordance with this privacy policy. We may update this policy from time to time without notice to you, so please check it regularly.

#### What information do we collect?

We will collect and process a range of information about you. This information is collected when you interact with us, open an account, submit an enquiry via the website, place an order for products or services and/or any further information requested from you. This includes: -

- Your name, address and contact detail, including email address and telephone number.
- Terms and conditions of your contract.
- Details of your bank account.
- Information about your usage of our website using cookies.

We collect 2 types of information from you when you visit our website:

- 1. Non-personal information: such as IP address (the location of the computer on the internet), pages viewed, and files downloaded. This helps us to determine how many individuals use our sites, how many people visit on a regular basis, which pages are most popular, and which pages are least popular. This information doesn't tell us anything about who you are or where you live, it simply allows us to monitor and improve our service.
- 2. Personal information: such as name, postal address, telephone number and e-mail address. We collect this information only in connection with specific activities, such as requests for quotations or information on our services'. The information is needed to fulfil your request. You don't have to disclose any of this information to browse our website. However, if you do choose to withhold requested information, we may not be able to provide you with certain services.

## How do we use the information we collect about you?

We may use the information provided by you:

 To process your order or manage your account, from ordering, processing, delivery and payment.
